## ***A Continuing Conversation About Publishing & Reporting On Archaeological Work***

Publishing and reporting on archaeological work is complicated. We began a discussion about this during the last Summit in May 2024. We heard from presenters and attendees who felt that publishing builds an academic knowledge base and guides cultural resources management; we also heard from attendees who feel that publishing is disrespectful to Tribal knowledge holders. We talked about accessibility of both academic publications and CRM reporting and responsible sharing or withholding of sensitive Tribal knowledge. This session will begin with a short, moderated panel discussion followed by Q&A and a plenary discussion. After a break at 2:45pm, we will gather with our Cohorts for some small group discussion around these topics.
